ABOUT THE GRANT

Frankston City Council are offering a new grant program aimed to support Frankston City's transformation into a vibrant, diverse, inclusive and safe destination after dark.

A thriving and dynamic night-

time offering comprises a range of experiences including dining, performances, live music, events, shopping, nightclubs, twilight markets, sporting events delivered by a range of diverse businesses and community and cultural groups.

This attracts visitors and entrepreneurs, creates jobs and drives the economic development of our city.

WHO CAN APPLY?

This grant is designed to financially assist local businesses, creative agencies, community groups and entrepreneurs build a vibrant nighttime economy by developing new and interesting experiences and destinations that encourage 'a good night out' in Frankston City.

To be eligible for funding, applicants must:


- Legally trade from or own premises located within Frankston's city centre (on this page), or;
- Be able to demonstrate how their Frankston city centre based project will bring significant night-time benefits to the city's businesses,



residents, visitors and/or workers. Be able to demonstrate and outline a collaboration project working with a Frankston City centre business. The applicant can be:

- ..
- A not-for-profit
- For-profit, or;
- Sole trader





WHAT CAN I APPLY FOR?

Applicants can seek funding for activations including, but not limited to;

- Offer an ongoing series of after dark events such as regular music programming, comedy or performance nights
- Introduce a new night-time experience or interesting concept to boost after dark activity within the city centre precinct
- Curate and coordinate activities
 between a group of businesses within

the city centre precinct

- Invest in capital works that are most impactful at night, such as digital illuminations and animations
- Operational costs for extended opening hours, including staff wages

HOW DOES THE GRANT WORK?

The grant covers up to 50 per cent of the total project cost to a maximum of \$30,000 for a night-time program that may run up to 12 months, or a short term

capital works project.

Reimbursed Council funded grants will be awarded to eligible businesses,

property owners, community or cultural organisations subject to Council approval until allocated grant funds are exhausted.

WHAT ARE COUNCIL'S DESIRED OUTCOMES?

Council's desired outcomes are strategically aligned with the Council Plan 2021-2025, where we seek to reimage how we use our spaces and precincts to increase productivity in the evenings. Council desired outcomes include:

- Add vibrancy and a sense of uniqueness to Frankston City
 - Create social cohesion, diversity and inclusion
 - Celebrate Frankston's artistic and creative culture
- Develop Frankston's tourism product mix and cultural offerings
- Support a safe and accessible environment
- Aid business recovery and impacts associated with the COVID-19 pandemic

HOW DO I SUBMIT MY APPLICATION?

Smarty Grants

Web Portal Applications must be submitted online via the SmartyGrants program. The program requires the user to create a username and password and applications can be saved throughout the process. WHAT IS THE ASSESSMENT PROCESS?

An expression of interest process is conducted to appoint an Independent Assessment Panel (IAP). The IAP is a diverse group of business and creative experts, independent of Council.

IAP members have qualifications and experience in the arts, accounting,

marketing, business strategy, proprietorship, commercial law, innovation and entrepreneurship.

Council's Chief Executive Officer appoints the panel and their identities remain confidential. The IAP assesses eligible applications and identifies those that best

meet the objectives of the program.

The IAP then makes a recommendation to Council, outlining which businesses should receive grants. Council will formally consider the recommendation when issuing the grants.

GRANT APPLICATION REQUIREMENTS

This grant application process is divided into two stages. The first stage is a concept stage and requires the submitter to supply a project idea and brief plan which aligns with Council's desired outcomes.

Stage one:

- Business or organisation contact details
- Australian Business Number (ABN)
- Brief project concept and plans
- Project location and site plan (if applicable)

- Start and end dates (if applicable)
- Anticipated attendance
- Project contributors /partners
- Benefits to the community and local business (including employment opportunities and inclusivity considerations)

The second stage requires the submitter to include a more in-depth plan to respond to the following;

Stage Two :

- Demonstrated alignment with Council desired outcomes (example)
- Budget and estimated expenditure
- Letters of support and/or owners consent (if applicable)
- Insurance and risk management plans
- Marketing plan
- Declaration
